I, the undersigned, in consideration for my (or my child's) voluntary participation in the Nets on Fire facility, do hereby willfully acknowledge that my signature below attests to my understanding and agreement that: I will not compromise myself in such a way as to do harm to myself, any other athlete or person, the host facility or the tournament.

- 1. I understand that that players or spectators may be dismissed from participation or the facilities, without refund, for violent conduct or unsportsmanlike behavior on or off the court.
- 2. I agree to pay for any and all damages to any property or persons caused by me willfully, negligently, or otherwise.
- 3. I know that basketball is a physical, contact, sport that involves the risk of injury; and I knowingly assume all risks and hazards associated with my participation in the sport.
- 4. I believe I am in proper physical condition to participate in basketball practices and games and have no illness, disease or existing injury or physical defect that would be aggravated by my participation. I will inform my coach if this status changes.
- 5. I further acknowledge that this risk may involve loss or damage to me or my property, including the risk of death, or other unforeseen consequences, including those which may be due to the unavailability of immediate emergency medical care.
- 6. I understand the league or tournament does not have personal injury insurance that covers my participation. Therefore, I should have a current, active, personal injury/health insurance policy in force, which covers my participation. Under any condition, I am responsible for any and all medical expenses arising from my participation, both in practices and games and while traveling to and from the facility.
- 7. I have the right and responsibility to inspect the equipment and facilities prior to events and, if I believe that anything may be unsafe, I will advise the referee or supervisor of the condition and may refuse to participate.
- 8. I know that my participation equals my consent.
- I authorize my photograph, picture or likeness, and voice to appear in any documentary, promotion (including advertising), television, video, or radio coverage of the tournament, without compensation.
- 10. I hereby release, waive liability, discharge, hold harmless, expressly indemnify, and covenant not to sue the B. Moore Foundation, Inc., Nets on Fire, any officer, director, employee, or any employee of the same, or the facility owners or any of their tenants or any associated directors,

- administrators, officers, managers, employees, coaches, trainers, volunteers, referees, sponsors or advertisers associated therewith, from any and all injury, damage or claim of whatever nature or kind, arising from my (or my child's) participation in the Nets on Fire Basketball Tournament.
- 11. I have completely read this document and fully understand its contents. I acknowledge that I have given up substantial rights by accepting this document and that I do so voluntarily.
